- A burial plot/grave is excluded from your plan.

- The deceased will be provided with a gown and cannot be dressed in their own clothes.
- Arrangements will take place during normal office hours.

**\*\*Our Simple plan has restrictions and limitations which include:**

- The hearse can only travel directly to the agreed cemetery or crematorium.
- Viewing of the deceased can only take place during office hours
- The date and time of the funeral is in agreement with the funeral director.
- Additional products such as orders of service or floral tributes must be independently organised.
